Adding a new health plan to your existing AIM ProviderPortal account

If you currently have an AIM direct registration *ProviderPortal* login account with another health plan, there is a quick and easy way for your facility to add Blue Cross NC to your AIM user account after November 1, 2022. This will enable your facility to enter requests as you typically do on *ProviderPortal* for Healthy Blue members.

From the AIM *ProviderPortal* home page:

- Select **Provider Management** on the home page.
- Select Add Provider Identifier.
- Select the appropriate provider identifier from the drop-down list (for example, TIN, NPI, etc.) and input the identifier value for your facility.
- Confirm the health plans your facility is associated with by placing a check box by the health plan name.
- Select Save.

Note: If you currently access the AIM **Provider**Portal by logging into another health plan's website (using single sign on), you will need to create a separate direct registration **Provider**Portal login account and will **not** be able to link your user accounts together.
