North Carolina Medicaid Clinical Coverage Policies

Blue Cross and Blue Shield of North Carolina (Blue Cross NC) will use the North Carolina Department of Health and Human Services (NCDHHS) clinical coverage policies as the starting point for Healthy Blue providers in a decision hierarchy for authorization review, which will include:

- 1. North Carolina Medicaid clinical coverage policy.
- 2. Federal Medicaid mandates.
- 3. Healthy Blue medical policy.
- 4. Carelon Medical Benefits Management, Inc. clinical guidelines.
- 5. Healthy Blue Clinical Utilization Management (UM) Guidelines.
- 6. Nationally recognized clinical guidelines (MCG).
