## *Hot Tip: Diabetic Supplies*

Healthy Blue members on non-preferred diabetic medication products may experience a pharmacy claim rejection. To avoid additional steps or delays at the pharmacy, please consider prescribing preferred products whenever possible. *Clinical Criteria* may need to be met for certain preferred products. Coverage should be verified by reviewing the *Preferred Drug List* on the Healthy Blue website (<https://provider.healthybluenc.com>). The *Preferred Drug List* is subject to change monthly.
