# **Electronic Data Interchange Information**

Availity serves as the electronic data interchange (EDI) platform for all electronic data and transactions for Healthy Blue providers.

## Methods to exchange EDI transmissions with the Availity Portal:

- Already exchanging EDI files? Providers can use existing clearinghouses or billing companies for Healthy Blue transmissions. Please work directly with your clearinghouse to ensure connectivity to the Availity Portal.
- Become a direct trading partner with the Availity Portal.
- Single claim entry is available through the Availity Portal.

Providers' billing companies and clearinghouses who are **not** currently exchanging EDI transactions with Availity will need to register for Availity. Once registered, the Healthy Blue icon will be added. Various guides on setting up businesses for exchanging EDI transactions are available to providers from the **Availity Essentials** secure portal.

- 835: Electronic remittance advice
- 276/277: Claim status Batch
- 270/271: Eligibility request Batch

### **Electronic funds transfer (EFT) registration**

To register or make changes for EFT only, go to **enrollsafe.payeehub.org** a secure EFT registration platform. The tool eliminates paper registration, reduces administrative time and costs, and allows providers to register with multiple payers at one time.

### Electronic remittance advice (ERA) registration

Providers can register and manage ERA accounts by using existing login at: <a href="https://www.availity.com">https://www.availity.com</a> Navigate to My Providers > Enrollments Center > Transaction Enrollment.

If previously registered to receive ERA, Healthy Blue providers **must** register using Availity to manage ERA account changes. You can also suppress (or enable) paper remittance vouchers through the *Provider Paper Suppression Form*.
