Timely Filing Deadline Calendar for 2023 to 2024

Effective since July 1, 2023, the chart below guides the Healthy Blue claims filing deadline for the 365-day timely filing limit for Blue Cross and Blue Shield of North Carolina.

A properly completed claim form must be submitted. For inpatient services, file the claim on a *UB-04* within 365 days from the date of discharge. For outpatient services, file the claim on a *CMS1500* within 365 days from the date of service.

Also, consider other health insurance (OHI) as primary. Timely filing begins on the date of the disposition from the primary insurer's *Explanation of Benefit*.

Note: If the 180th or 365th day falls on a weekend or holiday, the filing deadline is extended to the next business day.
