Hot Tip: Attention-Deficit Hyperactivity Disorder

Your Healthy Blue patients using non-preferred products to treat attention-deficit hyperactivity disorder (ADHD) may experience a pharmacy claim rejection if certain requirements are not met. Consider prescribing preferred products to help avoid additional steps or delays at the pharmacy. *Clinical Criteria* may need to be met for certain preferred products. Coverage should be verified by reviewing the *Preferred Drug List* on the **provider website**. The *Preferred Drug List* is subject to change quarterly at the discretion of the North Carolina Department of Health and Human Services.

Non-preferred ADHD products require trial and failure of two preferred drugs to be approved.
