Hot Tip: Attention-Deficit Hyperactivity Disorder

Your Healthy Blue patients on non-preferred products may experience a pharmacy claim rejection if certain requirements are not met. Consider prescribing preferred products to help avoid additional steps or delays at the pharmacy. *Clinical Criteria* may need to be met for certain preferred products. Coverage should be verified by reviewing the *Preferred Drug List* on the Healthy Blue provider website **provider.healthybluenc.com**. The *Preferred Drug List* is subject to change quarterly and at the Department's discretion.

Non-preferred attention-deficit hyperactivity disorder (ADHD) products require trial and failure of two preferred drugs to be approved.
